**Historical Records Commission Archive Award (See HRC award description 2023)**

- This award is selected and presented by the Historical Records Commission
- Ongoing development and preservation of an archival collection
- Special exhibits, publications, partnerships, and programs using archival records
- Public education and advocacy work to promote historical records preservation
- Innovative or creative technical advancements in digitization or preservation of archival materials
- Successful government archives and records management programs
- Response to emergencies and disasters relevant to historical recordkeeping

**1. Brainerd Jones Preservation Award**

- Completed acts of restoration or preservation
- Historic buildings, landmarks, trails, monuments, documents, vehicles, costumes, art, bridges, etc.
- Financial or material contribution advancing or enhancing historical restorations and preservation activities.

**2. Gaye Lebaron Scholastic Award**

- Recognition to an individual or group for a significant historical project or research which has led to publication of a book, magazine article, newspaper column, or pamphlet.

**3. Jean Thurlow Miller Award**

- Recognition for significant activities and accomplishments by an individual.
- Significant service on behalf of organized historic groups, museums, clubs, or historic projects.
- Significant financial or material contributions to historic groups or projects

**4. Mariano Vallejo Government Award**

- Recognition to a municipal, county, state or federal agency or individual for significant historical activities and accomplishments.
- Legislative initiatives protecting historic cultural resources.
- Financial incentives or contributions to historic projects

**5. Floyd Bailey Academic Award**

- Recognition to a student or teacher for a significant achievement which has expanded knowledge of Sonoma County's history.

**6. Carmen J. Finley Historical Website Award**

- Recognition for creating an outstanding website for a historic organization.

**7. Jack Taylor Media Award**

- Recognition for audio visual programing including movies and interviews.
